non-profit charity, and its directors, officers, employees, and agents (collectively, as AGR Arizona Greyhound Rescue.

I hereby freely and voluntarily, without duress, execute this Release under the following terms:

1. **Waiver and Release.** I hereby agree not to sue and irrevocably and unconditionally release, waive, and forever discharge and hold harmless Arizona Greyhound Rescue and its successors and assigns from any and all liability, claims, demands and causes of action, of whatever kind or nature, either in law or equity, whether known or unknown, which I or the Volunteer, if different, ever had, now have, or which may hereafter arise from the participation of the Volunteer with Arizona Greyhound Rescue and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with Arizona Greyhound Rescue. I understand and acknowledge that this Release discharges Arizona Greyhound Rescue from any liability or claim that I or the Volunteer, if different, may have against Arizona Greyhound Rescue with respect to any bodily or other injury, illness, death, or property damage that may result from the participation of the Volunteer. I also understand that Arizona Greyhound Rescue does not assume any responsibility or obligation to provide financial assistance or other assistance, including, but not limited to, medical, health, or disability insurance, in the event of injury, illness, death, or property damage.

2. **Insurance.** I understand that Arizona Greyhound Rescue may elect to provide group accident or other liability insurance for the benefit of its volunteers. Any coverage so provided will be governed by the policy language. Except to the extent that it may provide such insurance, Arizona Greyhound Rescue does not carry or maintain any health, medical, disability, damage or other liability insurance coverage for the benefit of its volunteers, and expressly disclaims any responsibility or obligation to do so. IF I AM THE PARENT OR LEGAL GUARDIAN OF A YOUTH VOLUNTEER UNDER THE AGE OF 18, I UNDERSTAND THAT I AM EXPECTED AND ENCOURAGED BY ARIZONA GREYHOUND RESCUE TO MAINTAIN MEDICAL HEALTH AND ALL OTHER APPLICABLE INSURANCE COVERAGE FOR MY OWN BENEFIT AND THE BENEFIT OF THE VOLUNTEER.

3. **Medical Treatment.** Except as otherwise agreed to by Arizona Greyhound Rescue in writing, I hereby release and forever discharge Arizona Greyhound Rescue from any and all liability claims, demands and causes of action whatsoever that may arise on account of any first aid or other medical treatment rendered during the participation of the Volunteer with Arizona Greyhound Rescue and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with Arizona Greyhound Rescue .

4. **Assumption of Risk.** I understand that the participation of the Volunteer with Arizona Greyhound Rescue and/or any project, activity, or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with Arizona Greyhound Rescue may include activities that may be hazardous to the Volunteer. I hereby expressly and specifically acknowledge that I assume the risk of injury or harm for the Volunteer in these activities and release Arizona Greyhound Rescue from all liability for injury, illness, death, and/or property damage that may result.

5. **Photographic Waiver and Release.** I understand that while participating in project, activity, or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with Arizona Greyhound Rescue, that Arizona Greyhound Rescue may film, photograph, or record the Volunteer's likeness or voice (the "Recorded Works"). I do hereby grant, assign, and convey unto Arizona Greyhound Rescue all right, title, and interest the Volunteer may hold in and to any Recorded Work made by or on behalf of Arizona Greyhound Rescue or made with its consent, during the participation of the Volunteer with Arizona Greyhound Rescue and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with Arizona Greyhound Rescue, including, but not limited to, any royalties, proceeds, or other benefits derived from such Recorded Works. I hereby agree not to sue and irrevocably and unconditionally release, waive, and forever discharge and hold harmless Arizona Greyhound Rescue and its successors and assigns from any and all liability, claims, demands and causes of action, of whatever kind or nature, either in law or equity, whether known or unknown, which I or the Volunteer, if different, ever had, now have, or may in the future have arising out of or related to the Recorded Works.

6. **Other.** I expressly understand and agree that this Release is intended to be as broad and inclusive as permitted by law, and that the Release shall be governed by and interpreted in accordance with the laws of the State of Arizona. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.
